### **Simulation Center Undertakings**

Colleagues,

The Medical Education Simulation Center has done some remarkable things already this year: we have hired Cris and John on as additional simulation specialists, thus increasing our utilization which allows us to open our doors to more opportunities. In fact, average staff utilization is at 97% even with adding several courses and simulations. We have had 37



tours/outreach visit the center thus far, and have exceeded last year's total revenue in the first five months of this academic year. Most importantly, we have added three simulation courses to the medical student curriculum for this academic year, and continue to provide high quality medical educational simulation to our students and faculty.



Looking toward 2014, the staff, along with Sue Ahearn, Clinical Skills Center, will be travelling to the International Meeting for Simulation in Healthcare (IMSH) in late January to present a podium presentation on integrating Simulation into OSCEs. This conference, hosted yearly attracts the very best that medical simulation has to offer. This will be the first podium presentation that the center has given at conference this scale.

In addition, the simulation center will participate in a panel discussion with other UC Schools concerning Prop 1D funding for telemedicine. Dr. Strom, the Associate Director of the simulation center, will be presenting a pre-conference workshop on micro debriefing with colleagues from Northwestern. We will also have two poster abstracts to present.

On the horizon and in line with our strategic plan, the center staff will be seeking out ways to include a telemedicine/simulation presence, initiating simulation opportunities at the medical center, will be submitting several unique manuscripts for publication, and will be seeking out a couple different grants, all while we maintain our commitment to the UC Irvine School of Medicine.

### **Simulation Instructor Training Course**

This course is very popular and a requirement to instruct at the simulation center. This 2-day course is designed to combine elements of theory, practice, and immersive experiential learning focusing on simulation as a teaching tool. The course will allow participants to learn about the history, context, and theory of patient simulation, debriefing strategies, and designing simulation curriculum. Participants will also have the opportunity to apply skills learned through deliberate practice.
