This is a busy time of year in the School of Medicine as the new academic year has just started. We have developed three (3) new courses for the medical students this year: Microbiology, Biochemistry, and Neuroscience. These new simulation sessions are designed to take the didactic information and knowledge and let the students apply them clinically in a safe setting. We are also currently developing/re-tooling a simulation programming



course, simulation operations planning and management course, and curriculum development course that we will eventually submit for CME approval.

Rationale

An orientation to the simulation space and equipment is an essential part of the simulation curriculum and session. An orientation is conducted at the beginning of every session for reasons of safety, adaptation to environment, center/session rules, and any specific session-specific information. Having students arrive after orientation has been concluded, is not only a safety concern, but is disruptive to the other students and instructors, and also has the potential cause for the session to not complete a number of terminal and/or enabling objectives.

Maintenance of Certification in Anesthesia (MOCA©)

The Medical Education continues to be endorsed by the American Society of Anesthesiology (ASA) to provide MOCA courses as part of the certification process for anesthesiologists around the country. Currently, the simulation center offers this course once a month.

Simulation Instructor Training Course

This course is very popular and a requirement to instruct at the simulation center. This 2-day course is designed to combine elements of theory, practice, and immersive experiential learning focusing on simulation as a teaching tool. The course will allow participants to learn about the history, context, and theory of patient simulation, debriefing strategies, and designing simulation curriculum. Participants will also have the opportunity to apply skills learned through deliberate practice.

The next course is scheduled for March 31st & April 1st 2014
